ASSAULT W WEAPON

On Saturday, June 9th, 2018 at 1537HRS York Regional Police were called to 2DHQ for the report of a domestic violence incident.

The Victim ALETRATIKHOSROSHAHI, Sheida (1979-09-19) attended 2DHQ to report a history of domestic incidents with her Husband RADMEHR, Mahyar (1974-Jul -27). ALETRATIKHOSROSHAHI was very tentative in her decision to speak with Police expressing concerns for her safety and the children's safety as she believed that RADMEHR might kill her, she was also worried that he would affect the status of her parents' permanent residency as when they were in the application phase he got angry and caused it to be significantly delayed. After speaking with a female friend who attended for support ALETRATIKHOSROSHAHI decided to provide a KGB statement.

Prior to the statement it was learned that they have been married for 11 years in July. They have been in separate rooms for the past 5-6 years where ALETRATIKHOSROSHAHI sleeps with the children. They remain married however ALETRATIKHOSROSHAHI has asked for a divorce mutually agreed upon initially RADMEHR agreed and then he changed his mind and refused an easy separation and threatened to attend her work (The Bay) and make a scene embarrassing her. The relationship is characterized by many verbal fights and some assaults both which have been in the presence of the children. The Victim believes that when RADMEHR is angry he has no control.

Through the statement three counts of assault were identified and one of uttering threats as well as an assault which occurred in Mexico and is not under the jurisdiction of these courts.

Count #1 Assault CC 266

On May 23rd, 2018 at 29 Woodhaven Cr, Town of Richmond Hill, Regional Municipality of York the Accused RADMEHR, Mayhar did assault the victim his wife ALETRATIKHOSROSHAHI, Sheida by using his body to push her into the wall in the main floor bathroom causing her to sit to the ground hitting her back and neck on the wall causing pain to her neck and back which limited her activities for two days afterwards this is contrary to the Criminal Code section 266.

Count #2 Assault CC 266

Between Sept 1st, 2008 and April 1st, 2009 at 29 Woodhaven Cr, Town of Richmond Hill, Regional Municipality of York the Accused RADMEHR, Mayhar did assault the victim his pregnant wife ALETRATIKHOSROSHAHI, Sheida by taking a

computer keyboard and hitting her over the top of the head while she was sitting on the floor beside the computer chair this is contrary to the Triminal Code section 266.

Count #3 Assault CC 266

On Nov 21, 2012 at 29 Woodhaven Cr, Town of Richmond Hill, Regional Municipality of York the Accused RADMEHR, Mayhar did assault the victim his wife ALETRATIKHOSROSHAHI, Sheida by placing both his hands around her neck and squeezing leaving bruising and marks which were documented at Mackenzie Health hospital this is contrary to the Criminal Code section 266.

Count #4 Utter Threats CC 264(1)

Between May 23rd, 2018 and May 25th, 2018 in the Town of Richmond Hill, Regional Municipality of York the Accused RADMEHR, Mayhar did threaten the victim his wife ALETRATIKHOSROSHAHI, Sheida by stating that he would burn the house down with the victim and their two children inside sleeping. The Victim believes this threat to be actionable and is concerned for her safety. As such this constitutes Utter Threats under the Criminal Code section 264(1).

Mexico - June 2017 - RADMEHR was outside the hotel room in the night when the victim and children were sleeping and he did not have a key and he knocked on the door it took some time to wake them up and when he came inside he went to the victim and started screaming at her in front of the children, he then took her cellphone and pushed it into her face and eye hard enough to leave a bruise.

The victim appears to be truly fearful for her own safety however expressed great concerns as she is going against the Persian culture by reporting the incidents.

At 1807HRS RADMEHR was arrested at the residence 29 Woodhaven Cr, Town of Richmond HIll without incident, he was transported to 2DHQ and booked in front of A/S/Sgt Walmsley #618 and placed in 2D8 cell. He was placed in contact with his lawyer of choice Martin HERMAN.

RADMEHR wished to speak with Police and 2CIB will follow up with an interview prior to his release. He will be released on a 10/11.1 with a court and fingerprint date of June 19th 2018 - 930 - 102 court.
