On November 22, 2012, police were dispatched to 29 Woodhaven Crescent in regards to an attempt suicide call. A female complainant had called 911 after she arrived at the above address, a short time after arriving the friend she was visiting laid on the floor and became unresponsive.

The complainant stated to the call taker that she thinks her friend took lots of pills.

Police were the first to arrive on scene, in the home were two small children, the complainant, and the unresponsive female. Police located the victim, Sheida, on the main floor, on the ground, close to the stairs that leads to the second floor. The children in the home were crying uncontrollably, the complainant at first was not able to answer any questions as she was very upset.

Sheida would not respond, her eyes were closed. A check of her vitals revealed that she was still breathing. Her pulse was slow and weak. She did open her eyes a few times, when being spoken to, but never responded back.

EMS arrived on scene and took control of the patient.

Police spoke to the complainant, she stated that she received a phone call form Sheida, she stated that if anything was to happen to her, she would like her children taken to her parents home. After hearing this, the complainant left her home address, as she knew something was wrong. At approximately 14:30 hours she arrived at 29 Woodhaven cresent. Sheida was okay, she was seen taking some sort of pill, when questioned on how much she took, Sheida said a few. A short time later Sheida laid on the floor and closed her eyes, the complainant attempted to wake her but could not. 911 called.

EMS transported Sheida to Mackenzie Health, where she was seen by Doctor Soberman.

PC Weston and Sgt Zadow stayed on scene at the family home, as Sheida's husband was informed what had happen and told to attend the home, not the hospital. The children in the home did witness the entire event. CAS was called.

At the hospital, the staff informed the writer that Sheida had marks on her neck, that could be from some sort of strangulation. Sheida was questioned about the marks, she stated, "Have you ever had sex". The hospital will contact DASA, as per protocol. The officers on scene were advised about the marks and asked to speak to the husband. He may have some incite on how she got the injury. At this time she did not complain about being assaulted.

### Formed

The medication that was used to overdose was in pill format, Benadryl (10 pills).

Count #3 Assault CC 266

On Nov 21, 2012 at 29 Woodhaven Cr, Town of Richmond Hill, Regional Municipality of York the Accused RADMEHR, Mayhar did assault the victim his wife ALETRATIKHOSROSHAHI, Sheida by placing both his hands around her neck and squeezing leaving bruising and marks which were documented at Mackenzie Health hospital this is contrary to the Criminal Code section 266.

Count #4 Utter Threats CC 264(1)

Between May 23rd, 2018 and May 25th, 2018 in the Town of Richmond Hill, Regional Municipality of York the Accused RADMEHR, Mayhar did threaten the victim his wife ALETRATIKHOSROSHAHI, Sheida by stating that he would burn the house down with the victim and their two children inside sleeping. The Victim believes this threat to be actionable and is concerned for her safety. As such this constitutes Utter Threats under the Criminal Code section 264(1).

Mexico - June 2017 - RADMEHR was outside the hotel room in the night when the victim and children were sleeping and he did not have a key and he knocked on the door it took some time to wake them up and when he came inside he went to the victim and started screaming at her in front of the children, he then took her cellphone and pushed it into her face and eye hard enough to leave a bruise.

The victim appears to be truly fearful for her own safety however expressed great concerns as she is going against the Persian culture by reporting the incidents.

At 1807HRS RADMEHR was arrested at the residence 29 Woodhaven Cr, Town of Richmond HIll without incident, he was transported to 2DHQ and booked in front of A/S/Sgt Walmsley #618 and placed in 2D8 cell. He was placed in contact with his lawyer of choice Martin HERMAN.

RADMEHR wished to speak with Police and 2CIB will follow up with an interview prior to his release. He will be released on a 10/11.1 with a court and fingerprint date of June 19th 2018-930-102 court.

Ms. said that Ms. stating the marks on her neck were from the children pulling on her clothing.
Ms. said that Ms. did tell her that her spouse is controlling with family finances and is emotionally abusive to her.
Ms. said that Ms. told her that she and her spouse have recently argued over care of the children.  The caller said that last night (Wednesday, November 21st)  Mr.  Radmehr whom she said called her urg saying he could not find the diapers. Ms. said that two days earlier Mr. Radmehr called her, expressing concern that one of the children may have gotten into some moth balls in the family home.
Ms. understands that a paternal aunt was caring for the children while Ms. and Mr. Radmehr were involved with police and/or the hospital. However she understands that Mr. Radmehr had been released by police so that he could care for the children.
Ms. said that Ms. but she suspects that she may be released from hospital later tonight.
This worker found no local Society record for the family.
This worker then spoke with Officer Howard#1793 at the Richmond Hill police station and asked about police involvement in today's incident. Officer Howard said he was not involved but advised that the police record of occurrence 12-330492 in which Mr. Radmehr was today charged with assault on his spouse was reported to Society worker Cheryl MacDonald. Officer Howard said that Officer Richard Poole appears to be the lead officer on this file and he is no longer on duty today. Officer Howard said that Mr. Radmehr was released with the conditions that he not come within 500 meters of Ms.    A condition of the presumably has not yet appeared in court).

home to meet with Mr. Radmehr on November 23, 2012 to discuss the situation further.

A subsequent referral was received on November 23, 2012 (see referral), released from the hospital. This worker attended the family home unannounced on November 23, 2012 to meet and the two children. Mr. Radmehr was charged with assault and is not to have contact with his wife or be within 500 meters of her at any time. He is currently residing with paternal grandmother. Ms. was very attentive to her children throughout the visit. The children appeared to be comfortable with Ms. and sought out her affection consistently. Ms. explained that she and her husband had an argument the evening of November 21, 2012 when Mr. Radmehr could not find a diaper for their daughter. She stated there was no physical violence at any time on this night or in the past. She explained that the marks on either side of her neck were from her children who were climbing on her yesterday. She stated she had to stop them after they began grabbing her neck and sweater as she noticed marks. Ms. Mr. Radmehr had not physically assaulted her at any time and did not cause the marks on her neck. She did state the children were witness to the argument, but that they did not cry nor did they appear scared. to deal with the stress of the argument she had with her husband. Ms. stated she and her husband need to work on their relationship and is willing to participate in marriage counseling to strengthen their communication. Ms. spoke positively of her husbands ability to parent their children. This worker observed Melina's crib to be missing one side, and was pushed against the mother's bed. Discussions surrounding safe sleep occurred explained that Melina can climb out of her crib on her own, and she is worried that she will hurt herself if she attempts to due so. Ms. stated she is in the room at all times when her daughter is sleeping. She also displayed sufficient supplies (e.g diapers) for the child. In consultation with Protection Supervisor, Shawna Martin, the children are safe at this time while in the care of Ms. . She will speak with her family and friends for support. Ms. signed consent for this worker to speak with Mackenzie Center Hospital, her family physician and Maana's daycare staff for further assessment. This worker will also speak to her husband, Mr. Radmehr.

Mr. Radmehr spoke with this worker on November 23, 2012. He said he was charged with assault, but denied any violence occurred in the home at any time. He was released with conditions not to return home and arrange access with the children through a third party. Mr. Radmehr stated he was not home during the incident that occurred but stated he had no concerns for his wife's ability to parent their children. He stated she does not consume alcohol except a glass of wine on the holidays. He stated no mental health concerns however he noted her mood has been "more sad" since giving birth.

I feel that she handled the situation quiet well based on what she thought was the right thing to do, namely notify the paramedics immediately.

On June 11, 2018, you retained my services in regards to charges you were facing which included two counts of Assault, one count of Assault with a Weapon and one count of Uttering Threats. The first court appearance for this matter was June 19<sup>th</sup> and I attended at that time and received what disclosure was available and filed a Designation on your behalf. As you know, I attended shortly thereafter and varied the bail. You have a copy of that bail variation.

As time went on we had numerous meetings where you continued to provide me with information in regards to your wife and your previous relationship. In the meantime, I had numerous attendances at court awaiting the video that your wife had made at the police station. I attended on July 10<sup>th</sup> and July 31<sup>st</sup> and August 14<sup>th</sup> when I finally received the video. This video was reviewed by myself and I met with you to review it. Thereafter I started having meetings with the Crown Attorney. During these meetings I continued to receive numerous e-mails from yourself, wishing me to pursue avenues which I did not necessarily agree with.

At the end of the day, the Crown agreed to withdrawn the charges from the 2012 incident, as well as the charge from 2008. It was agreed that the only two charges that the Crown would proceed with would be the charges of May 23, which included Assault and Threatening. It was my belief that the Crown was prepared to offer me a Section 810 Peace Bond or a common law Peace Bond in regards to these charges because of the minor nature of the allegations made. However, in our numerous meetings and in particular our last meeting, you made it abundantly clear that he would not accept a Peace Bond as a resolution to these matters.

On October 11, 2018, I advised you of all these matters and you indicated to me that you would probably have your family law lawyer take over the defence of the criminal charges as your family lawyer thought it would be better for you if he handled all aspects of the case.
