

**Keith:** Welcome to Kijiji's Live Chat! I would be delighted to help, please allow me a quick moment to review your request before we get started.

**Me:** Good day\I am a victim of fraud and need help. There are ads with my phone number on a Google print out which I have never advertised, owned or sold. Can your team look at them and verify if they exist on your data base under my number. My name is Mahyar Radmehr and my number is 416-880-3134. I have no direct e-mail from kijiji to forward them to for your review.

**Me:** Hi

**Keith:** Mahyar, the only ad currently advertised on Kijiji under phone number is 416-880-3134 is "Stainless steel barbeque with Propane canister" (# 1552710376 )

**Me:** I know that but my concern are other fraudulent ads displaying my phone number. I have contacted the Police but was told that I need some sort of verification if there have ever existed under my phone number and if so, what e-mail and IP are associated with those ads. The date of placement of those ads would also be helpful

**Keith:** This is most likely that your phone number coming up on other users' ads because you have a Google business listing. I

**Keith:** That is actually external to Kijiji as Google adds "advert" to ad slots embedded on the Kijiji pages when users look for ads for similar to services/items they offer, in these cases, users may confuse the Google ads with the users contact details instead of the ad posters contact details below the Google ad.

**Me:** No, I have been formally accused of theft in my divorce proceeding and the ads in question were submitted as exhibits but I never owed or advertised or sold the items.

**Keith:** Not much we can do but advise that you report this and complain to google or remove your contact number from your business listing on Google so that Google does not add your contact details to sites like Kijiji on the internet.

**Me:** I have No business .

**Me:** I believe that these ads were place under other e-mail with my number entered in the ad.

**Keith:** Then ask the next caller to let you know the Kijiji ad number in question and bring that to us

**Me:** Can some one from your team at least look at them please?

**Keith:** All Kijiji ads have a listing ID, which is 1552710376 for your "Stainless steel barbeque with Propane canister" for example

**Keith:** All what we would need is that number for any ads you may be having calls for if from Kijiji

**Keith:** Then we will take the according action to remove them

**Me:** That is not shown on the google print out. All I want to know is if the print out is made up or if another e-mail unknown to me is placing ads with my phone number. My concern is not removal because I had no inquiries about them

**Keith:** The answer to your question is no no

**Me:** You see; Is it possible for someone to set up an account with an e-mail address, place an ad with some else's phone number within the ad description?

**Keith:** Yes that is possible

**Keith:** But we would mostly likely be able to see the ad

**Keith:** In that case

**Me:** Is there a way you could look at them please?

**Keith:** If we cannot find it, then the caller will be able to let you know

**Keith:** That is exactly what I did

**Keith:** I did not care about mahyarradmehr@hotmail.com



**Keith:** Yes that is possible

**Keith:** But we would mostly likely be able to see the ad

**Keith:** In that case

**Me:** Is there a way you could look at them please?

**Keith:** If we cannot find it, then the caller will be able to let you know

**Keith:** That is exactly what I did

**Keith:** I did not care about mahyarradmehr@hotmail.com

**Keith:** You said "My name is Mahyar Radmehr and my number is 416-880-3134."

**Me:** yes that is me

**Keith:** And I search 416-880-3134., which only showed "Stainless steel barbeque with Propane canister" (# 1552710376 )

**Me:** Now this accusation was made against me between June 2018 and mid 2019 and the case is still ongoing

**Me:** I have No direct e-mail from kijiji to send you the ads in question as an attachment

**Keith:** Send it to me here

*Your file has been successfully uploaded to the agent.*

**Me:** do you see the attachment?

**Keith:** Yes

**Me:** I was told by the Police that they have seen similar cases where Google print outs have been design to show an ad but ad ad may have never existed. I just want to be certain of the items portrayed in the attachment have ever existed in your database under 416 880 3134

**Me:** yes I see the link regarding a lawyer review which is mine

**Keith:** Nothing else is currently showing on our end on Kijiji related to your phone number. You need to contact Google to remove the cached version of the information since those links seem to be about former Google Cash links. Please visit the following Google help page to remove the content:

**Keith:** I cannot see any of those items to have ever existed on Kijiji

**Me:** Thank you but as mentioned I cannot find those ads under my phone number. Just want to know if any of those items have ever existed in your database since 2018 until present under my phone number.

**Keith:** It could have been the case, but we do not have access to expired posting since our database would not support ads posted years back

**Keith:** Once they expire on our site they get removed from our database

**Me:** Thank you kindly for your help

**Keith:** You're very welcome !
